

Welcome to Another School Year!

I would like to open introducing myself briefly. My name is Kim Chesko, and this is my

11th year teaching general music at Jefferson Rd. I come to the position of Resolutions Specialist after holding a number of other leadership positions in PDTA, including Public Relations Committee Chair, Vice President for Administration, and (briefly) President when Jolene was elected to NYSUT leadership.

I am dedicated to continuing to serve the PDTA membership in the same manner that Dwayne Cerbone has representing your rights while fostering a great teaching environment for you and a great learning environment for our students.

In this article I want to clarify some

information regarding traveling teachers. Last September, PDTA created a document to provide some guidance to members regarding our current practice for all teachers who travel. This document was sent to you in the beginning of September. If you are a traveling teacher, and have not seen this document, ask your building rep right away for a copy.

Some highlights:

Travel time - Our practice is to allow a minimum of 30 minutes of travel time between teaching assignments. Sometimes this is not feasible with schedules - in these cases please contact your building rep, as a travel time of less than 30 minutes will trigger a conversation between the District and PDTA about appropriate accommodations to assist a traveling teacher.

Mileage - Don't forget to log your mileage! Mileage between school should be kept track of regularly and submitted monthly when possible. A mileage form can be accessed here.

Lunch and Prep - Have you made sure you have your contractual lunch and prep time? Check the contract to see how much time you are entitled to and check your schedule to make sure it is there. It is our practice that lunch and prep cannot be diminished by travel.

Our Traveling Teachers Document offers further guidance on parking, home schools, and substitutes that would be useful to a traveling teacher. Please make sure to read over this document and contact the PDTA office if you have any concerns about your traveling teacher schedule.

Professional Learning Updates

The summer is traditionally our busiest time of year for professional learning activities and provides us with multiple opportunities for growth, reflection, and innovation. This summer the Teacher Center offered 164 activities for staff members on topics such as webpage design, mental health issues, assessment, grading, Office 365, and content-specific sessions. These workshops provided 579.5 hours of professional learning class time attended by approximately 2500 participants.

As an Association we are fortunate to have a culture that supports continuous learning and provides us with opportunities to increase our knowledge and expertise. We are then better prepared to meet the needs of our students and provide the high quality education our students deserve.

Knowing that the most effective professional learning needs to be ongoing throughout the year, our opportunities to maintain this commitment do not end in August.

There are multiple ways in which you can participate in learning that is job-embedded and aligned to your specific needs during the school year. Collegial circles and individual initiatives are two structures that allow teachers to continue their learning along with activities offered through the Teacher Center in the fall and spring. Para Academy workshops run monthly throughout the year and are an opportunity for SRPs to stay up to date on identified topics.

Important things to keep in mind regarding professional learning and Teacher Center credit:

- All staff should check their hours in WinCap PD regularly to be sure they accurately reflect the work they have completed.
- Professional staff members who have not yet completed their contractual requirement for professional learning should have a plan in place for doing so. All PD for this school year needs to be completed by May 31, 2018 so it is important to plan ahead.

- Forms and information for collegial circles and individual initiatives
 - are on the Teacher Center webpage. Please check that page to access what you need and if you can't find what you are looking for, call the Teacher Center.
- Professional Certificate holders need to complete 100 CTLE hours every five years. This information is in WinCap PD under 'My Certifications' so it is important to be sure those hours are accurate.

I am looking forward to being your Professional Growth Chair and to continue supporting you as the Teacher Center Director. Weingarten Rights

You have rights won for you by your union! Under the law, you have a right to union representation at an investigatory interview with a supervisor if you reasonably believe that the interview will lead to discipline. This right is triggered when you request union representation. The representative must be a union leader. If you believe you may be disciplined, you should ask, "Could this meeting result in discipline? If so, I request my union representative be present." A reasonable period of time shall be afforded to you to obtain such representation. That means you never have to meet with the supervisor right away, and you are also entitled to know the subject of the meeting.

These are known as your Weingarten Rights.

- If you are a newly hired fulltime SRP employee, you are automatically enrolled in the ERS (Employees' Retirement System). However, if you were hired parttime, you may enroll but it is not mandatory. Contact Payroll/ Benefits at x1042 for more information.
- As you begin the school year, please keep in mind that if you are assigned to work a certain number of hours per day, for example 6 hours, your duties should not exceed this time without administrator approval. You are encouraged to check

- your hours and not assume they are the same as last year. Please contact one of your building reps and your administrator if your job is requiring you to work beyond your designated hours.

How's Your Cert?

All permanently or professionally certified teachers or educational leaders and Level III teaching assistant certificate holders are required to register with SED in the month of his/her birth. This registration process will be done using the State Education Department's TEACH system. These certificate holders will be required to register every five (5) years thereafter.



Don't forget Health Fund money is not deposited until mid October. At that time your funds will be available to you. Full-time staff members who are not on the payroll as of October 1, but who are on the payroll before February 1 of the school year, shall be eligible for a pro-rated portion of the health fund, according to the following schedule:

On the payroll before November 1: 80% of the benefit On the payroll before December 1: 70% of the benefit On the payroll before January 1: 60% of the benefit On the payroll before February 1: 50% of the benefit

Part-time staff members of .5 or more shall receive a prorated contribution of the above schedule.

In order to receive this prorated contribution, staff members must fill out and submit the "Request for Prorated Health Fund Benefit" form found at https://www.pdta.org/forms by March 1 of the school year.
