### PDTA Building Representation Dwayne Cerbone, President

Each building in our district has an elected PDTA Building Representative. Our unit is also strengthened by having SRP Representatives at most sites as well as an Ancillary Representative for members who are typically assigned to Barker Road East. I am proud to work with and in support of these effective, dedicated, knowledgeable, compassionate and dynamic memberleaders who provide amazing service to our members. I believe the heart of your union value is most readily observable in the work these individuals do daily. They are the first line of access, guidance, oversight,

protection and advocacy for members

when scenarios arise.

is important to proactively understand your right to access the services of these leaders as it often becomes more challenging to determine how to leverage these supports when directly involved in an emotionally charged situation. Many of the general responsibilities of a PDTA Building Representative are clearly defined here, in the PDTA Constitution By-Law 7. In short, your PDTA Building Representative's role is to represent your contractual, work environment and professional interests at the most local level: where you are. They also advocate for positive changes on behalf of our members and work closely with building administrators on topics that most directly impact your employment.

Your Weingarten Rights are derived from the Supreme Court's 1975 Weingarten decision where the court recognized union employees' rights to representation in certain situations. Weingarten rights include the right to have a coworker, in our

case a union representative, present at an investigatory interview or any meaning that the employee reasonably believes might result in discipline. If a supervisor/administrator asks to meet with you and you are not initially encouraged to invite representation, we recommend you ask the following questions:

- · What is this meeting regarding and could it result in discipline?
- · Will I need union representation?

If the answers are anything but "no", seek representation prior to beginning the meeting.



If you innocently begin a meeting with your supervisor/administrator without asking these questions and later suspect that you need to do so, you are permitted to request the meeting "pause" so that you may secure union representation in a timely manner. If the administrator says something like "this is urgent" or "it cannot wait," you should make your request for representation exceedingly clear and again request time to speak to your union representative. They should then allow you reasonable time to secure the appropriate representation.

Despite any perceived relationship with your supervisor or administrator, you should still secure union representation

prior to meeting in these unique scenarios. The proverb "better safe than sorry" seems advisable. In fact, we encourage members to secure guidance and support from their Building Representative any time they are discussing a topic that has revealed a significant conflict with their supervisor. A unique instance and a recent topic of discussion in our leadership team is the recommendation that members obtain union representation prior to engaging with an administrator following an incident of workplace violence and/or an injury directly resulting from your work with students.

Unfortunately, some members are hesitant to reach out for our support, as they do not want others to be aware of what is happening, they believe they can manage it on their own, or they are confident they have not done anything wrong. Though I respect these personal inclinations, my vast experience demonstrates this may not be in your best interests in certain scenarios. We assure you, as your representatives, unless we are released to act specifically on your behalf, we are obligated to keep all matters discussed confidential. We are here to support you, even if just to discuss options or to serve as a trusted ally.

As we have settled into this school year, I'd like to share some contract related

reminders. These are inspired by questions that I have been asked recently by members or scenarios I have been working on. As always, if you have any questions or concerns about these items, please email me or contact your building representative.

#### **Extra Duty Contracts**

An extra duty contract is generated and distributed to members who have an overage (CBA 6-7) or overload (generally negotiated as cases arise), or are a para with unique responsibilities (CBA 25-2-5). These contracts will come directly from Human Resources and should have been delivered to all members receiving them by this point. If you have not received an extra duty contract and are expecting one, please contact your building representative or reach out to me directly. Additionally, please check and make a copy of your contract before you sign it and return it to HR. If anything seems incorrect, please DO NOT SIGN your contract and contact your building representative or me.

#### **Checking Paychecks**

Continue checking your paycheck for accuracy, especially if you have reason to expect additional compensation for any purpose. If you have questions about a paycheck, begin by asking your building representative. Please note a change this year — if an SPR subs for a teacher, this will be listed on a paycheck and compensated as 6.5 hours instead of the 7 that you may have seen last year. This is correct; the district legally cannot pay a member for lunch and that practice has been corrected this year.


#### **Duty Free Lunch and Prep Time**

Make sure that your schedule includes the appropriate allotted time for an uninterrupted, duty-free lunch (CBA 5-1-1, 25-7, 48-2) and appropriate planning time for certificated staff (CBA 5-6). PDTA urges you to take your lunch! It is a great time to connect with colleagues, temporarily detach from the stressors of our jobs, and take care of yourself physically and mentally. If you have any concerns about your assigned schedule, once again, reach out to your building representative or directly to me.

## **PDTA Study Grant**

With the PDTA Study Grant, we attended the Institute for Multi-Sensory Education (IMSE) Comprehensive Orton-Gillingham Course and Program. It is a 30-hour, hands-on, interactive, and personalized class that provides a complete understanding of the Orton-Gillingham Method, the essential five components of literacy, and the tools necessary to apply it to the classroom.



Orton-Gillingham is a structured, multisensory approach to teaching reading and writing, particularly designed for individuals with dyslexia or other reading difficulties. Developed by Dr. Samuel Orton and Anna Gillingham in the early 20th century, this method emphasizes the systematic teaching of phonics, spelling, and vocabulary through visual,

auditory, and kinesthetic activities.

After participating in this accredited Structured Literacy course, have a deeper understanding of the structure and foundation of the English language,



well as the research behind the Science of Reading. This provided us with an enhanced knowledge of how to assess and teach students in all three tiers of RTI along with students with dyslexia. In addition, there is a component that broadened our understanding of how English as a New Language students best acquire language and literacy skills.

In addition to the extensive knowledge gained from the course, we were also provided with an immense list of resources and materials for use during instruction to further engage students in learning and retention. The variety of resources and materials are used to facilitate the Orton-Gillingham multisensory approach to teaching reading and writing.

We appreciate PDTA's support in this endeavor to better support our students. The knowledge we gained from this highly informative course is invaluable. We are grateful for our union!
